Ordinance No. 584

(Duly Adopted December 27, 2023)

AN ORDINANCE REVISING THE COMPENSATION OR COMPENSATION RANGES FOR CERTAIN POSITIONS OF EMPLOYMENT OR APPOINTMENT BY THE BOROUGH, EFFECTIVE JANUARY 1, 2024, INCLUDING CERTAIN ADMINISTRATION EMPLOYEES, MAINTENANCE EMPLOYEES, THE CHIEF OF POLICE, AND PROFESSIONALS; AND CONFIRMING THE EXISTING FIDELITY BOND REQUIREMENTS FOR CERTAIN BOROUGH EMPLOYEES.

WHEREAS, Borough Council desires to revise the compensation or compensation ranges for certain positions of employment or appointment by the Borough as set forth below, effective January 1, 2024; and

WHEREAS, Borough Council desires to confirm the existing fidelity bond requirements for certain Borough employees; and

WHEREAS, on December 20, 2023, the Borough published a public notice in the East Penn Press, a newspaper of general circulation in the Borough of Alburtis, of its intention to consider and adopt this Ordinance on December 27, 2023;

Now, THEREFORE, be it ORDAINED and ENACTED by the Borough Council of the Borough of Alburtis, Lehigh County, Pennsylvania, as follows:

- (21) 2024. The rate of compensation of the Borough Treasurer for the year 2024 shall be \$21.49 per hour.

(j) 2024. The annual salary of the Chief of Police for the year 2024 shall be \$84,452.55.

§ 11-106 Maintenance Department.

(w) 2024. The rate of compensation for each member of the Maintenance Department for the year 2024 shall be established by motion or resolution of Council within the following range of compensation for the person's employment classification:

Maintenance Supervisor\$26.34 - \$35.07 / hour

Maintenance Full Time A\$25.23 - \$30.92 / hour

Maintenance Full Time B\$24.40 - \$25.87 / hour

Maintenance Full Time C\$21.86* - \$24.40 / hour

Maintenance Part Time\$11.35 - \$17.15 / hour

* In the case of a person who has a current Class A or Class B commercial driver's license (CDL) when first hired by the Borough, the minimum hourly rate shall be \$23.55. In the case of a person who obtains such a license after being hired by the Borough, the minimum hourly rate shall be increased to \$23.55 after the *later* of the date the person obtains the license or the date three months after the person's first day of employment as a Borough maintenance department employee.
