## Article I — Annexations

### § 2-101 14.0378 Acres to the Southeast.

(a) **Petition Approved.** The Borough of Alburdis hereby approves the petition of the sole freeholder of the territory proposed to be annexed to the said Borough, Lehigh County, Pennsylvania, being that portion of Lower Macungie Township, Lehigh County, Pennsylvania, adjacent to and southeast of the said Borough, bounded and described as set forth in Section 1 of Ordinance 77, which is incorporated herein by reference.

(b) **Approval by the Court.** If the annexation of the said territory is approved by the Court of Quarter Sessions, the said territory shall be admitted, annexed to, and added to the Borough of Alburdis as a part of the said Borough, and the same shall, upon compliance with the legal requirements be subject to the jurisdiction of the authorities of the said Borough of Alburdis and shall be entitled to the privileges of the same.

(c) **Certification; Filing; Notice.** The proper officials of the Borough of Alburdis, as required by law, are hereby authorized and directed to certify to the Court of Quarter Sessions, County of Lehigh, Pennsylvania, the said petition, as approved hereby, and to file in the said Court, a certified copy of Ordinance 77, together with any maps, plots, and descriptions required by law to be filed, and to give proper notice of such annexation to the County board of elections of the said County.

## § 2-102 37± Acres to the West.

(a) **Petition Approved.** The petition for the annexation to the Borough of Alburdis of a certain tract of thirty-seven (37) acres, more or less, signed by a majority of the freehold owners, namely: Raymond A. Kemp, Betty J. Kemp, Paul W. Gambler, Catherine Gambler, Amy Kercher, Elmer Kercher, Harold J. Dankel, Lorraine Dankel, Alburdis Recreation Association, Manko Enterprises Inc., and East Penn Unit School District Authority, is hereby approved.

(b) **Application to the Court.** Due application, by petition, shall be made on behalf of the Borough of Alburdis to the Court of Quarter Sessions in and for the County of Lehigh for the approval and confirmation by the Court, of proceedings for annexation, in accordance with the provisions of the Act of 1953, July 20, P.L. 550, Sec. 1ff, 53 PS 67501ff, that the tract of land bounded and described as set forth in Section II of Ordinance 124, which is incorporated herein by reference, now lying within the Township of Lower Macungie, shall be a part of and subject to the jurisdiction and authority of the Borough of Alburdis.

### § 2-401 Tax Certifications.

The Borough of Alburdis hereby appoints the Tax Collector for the Borough of Alburdis as the municipal officer authorized to provide tax certifications upon request to the public. The Borough Council further authorizes the Tax Collector to assess, collect, and retain, as compensation for providing such additional service, a fee of Fifteen Dollars (\$15.00) per tax certification.
