Article I — In General

§ 11-101 Mayor.

(a) 1/1/2002. Effective January 1, 2002, the compensation of the Mayor shall be One Thousand Eight Hundred Seventy-five Dollars (\$1,875.00) per year, payable in monthly installments.

§ 11-102 Council.

(a) **1/1/2002.** The compensation of members of Borough Council shall be One Thousand Eight Hundred Seventy-five Dollars (\$1,875.00) per year, payable in monthly installments, effective for any given member of Borough Council on the first day after January 1, 2002 that the member begins a new term of office.

§ 11-103 Tax Collector.

(a) **1/5/1998.** Effective January 5, 1998, the compensation of the elected Tax Collector of the Borough for the collection of Borough taxes which the elected Tax Collector is authorized to collect shall be a commission of three per cent (3.0%) of the Borough taxes so collected and remitted to the Borough.

§ 11-104 Administration.**(a) Borough Manager.**

(1) **2003.** The rate of compensation of the Borough Secretary for the year 2003 shall be \$15.60 per hour.

(2) **2004.** The rate of compensation of the Borough Secretary for the year 2004 shall be \$15.91 per hour.

(3) **2005.** The rate of compensation of the Executive Secretary for the year 2005 shall be \$17.50 per hour.

(4) **2006.** The rate of compensation of the Executive Secretary for the year 2006 shall be \$18.20 per hour.

(5) **2007.** The rate of compensation of the Executive Secretary for the period from January 1, 2007 through October 28, 2007 shall be \$18.56 per hour.

(6) **10/29/2007.** Effective October 29, 2007, the rate of compensation of the Executive Secretary shall be \$17.50 per hour.

(7) **2009.** The rate of compensation of the Executive Secretary for the year 2009 shall be \$18.03 per hour.

(8) **2010.** The rate of compensation of the Executive Secretary for the year 2010 shall be \$18.57 per hour.

(9) **2011.** The rate of compensation of the Executive Secretary for the year 2011 shall be \$19.50 per hour.

(10) **2012.** The rate of compensation of the Executive Secretary for the year 2012 shall be \$20.18 per hour.

(11) 2013. The rate of compensation of the Executive Secretary for the year 2013 shall be \$20.79 per hour.

(12) 2014. The annual salary of the Executive Secretary for the year 2014 shall be \$52,000.

(13) 2015. The annual salary of the Borough Manager for the year 2015 (including service as the Executive Secretary through January 28, 2015) shall be \$53,612.

(14) 2016. The annual salary of the Borough Manager for the year 2016 shall be \$60,000.

(15) 2017. The annual salary of the Borough Manager for the year 2017 shall be \$61,800.

(16) 2018. The annual salary of the Borough Manager for the year 2018 shall be \$63,036 through June 30, 2018 (\$31,518 pro-rated portion for six months) and \$63,654 from and after July 1, 2018 (\$31,827 pro-rated portion for six months).

(17) 2019. The annual salary of the Borough Manager for the year 2019 shall be \$65,564.

(18) 2020. The annual salary of the Borough Manager for the year 2020 shall be \$67,531.

(19) 2021. The annual salary of the Borough Manager for the year 2021 shall be \$69,557.

(20) 2022. The annual salary of the Borough Manager for the year 2022 shall be \$71,915.

(21) 2023. The annual salary of the Borough Manager for the year 2023 shall be \$74,353 for the person serving as Borough Manager on January 1, 2023, and \$65,000 for any person hired as Borough Manager in 2023. The annual salary of a person serving as Assistant to the Borough Manager shall be \$65,000.

(22) 2024. The annual salary of the Borough Manager for the year 2024 shall be \$67,171.

(23) 2025. The annual salary of the Borough Manager for the year 2025 shall be \$75,000.

(24) 2026. The annual salary of the Borough Manager for the year 2026 shall be \$77,250.

(b) Fiscal Consultant.

(1) 1/1/2003. Effective January 1, 2003, the annual salary of the Borough Treasurer shall be \$1,200.00. The title of this position was changed to Fiscal Consultant on August 12, 2009. For the compensation of the position of Borough Treasurer after August 12, 2009, *see* subsection (c) below.

(2) 8/13/2009. Effective August 13, 2009, the annual salary of the Fiscal Consultant shall be \$1,200.00.

(c) Borough Treasurer.

(1) **2003.** The rate of compensation of the Clerk/Accountant for the year 2003 shall be within a range from \$12.71 to \$15.00 per hour, with individual rates to be established by motion or resolution of Council.

(2) **2004.** The rate of compensation of the Clerk/Accountant for the year 2004 shall be within a range from \$12.96 to \$15.30 per hour, with individual rates to be established by motion or resolution of Council.

(3) **2005.** The rate of compensation of the Clerk/Accountant for the year 2005 shall be within a range from \$13.35 to \$15.76 per hour, with individual rates to be established by motion or resolution of Council.

(4) **2006.** The rate of compensation of the Clerk/Accountant for the year 2006 shall be within a range from \$13.88 to \$16.39 per hour, with individual rates to be established by motion or resolution of Council.

(5) **2007.** The rate of compensation of the Clerk/Accountant for the year 2007 shall be within a range from \$14.16 to \$16.72 per hour, with individual rates to be established by motion or resolution of Council.

(6) **2008.** The rate of compensation of the Bookkeeper/Earned Income Tax Officer for the year 2008 shall be within a range from \$14.58 to \$17.22 per hour, with individual rates to be established by motion or resolution of Council.

(7) **2009.** The rate of compensation for the year 2009 of the position known as the Bookkeeper/Earned Income Tax Officer prior to August 13, 2009 and known as the Borough Treasurer after August 12, 2009 shall be within a range from \$15.02 to \$17.74 per hour, with individual rates to be established by motion or resolution of Council.

(8) **2010.** The rate of compensation of the Borough Treasurer for the year 2010 shall be within a range from \$15.47 to \$18.27 per hour, with individual rates to be established by motion or resolution of Council.

(8) **2011.** The rate of compensation of the Borough Treasurer for the year 2011 shall be within a range from \$15.93 to \$18.82 per hour, with individual rates to be established by motion or resolution of Council.

(2) 2018. The rate of compensation of the Administrative Assistant for the year 2018 shall be \$11.22 per hour through June 30, 2018 and \$11.33 per hour from and after July 1, 2018.

(3) 2019. The rate of compensation of the Administrative Assistant for the year 2019 shall be \$11.67 per hour.

(4) 2020. The rate of compensation of the Administrative Assistant for the year 2020 shall be \$12.02 per hour.

(5) 2021. The rate of compensation of the Administrative Assistant for the year 2021 shall be \$12.38 per hour.

§ 11-104.1 Chief of Police.

(a) **2015.**

(1) **In General.** The rate of compensation of the Chief of Police for the year 2015 shall be \$31.10 per hour.

(2) **Retroactive Payment for Period Before Execution of Police Collective Bargaining Agreement.** The provisions of this subsection (a) are retroactive to January 1, 2015. Accordingly, the difference between the compensation earned under this § 11-104.1(a) from January 1, 2015 through the last pay period which ended before the enactment of Ordinance 528 (less all applicable deductions), and the amount actually paid for that period of time, shall be paid to the Chief of Police in the paycheck for the pay period which includes the date Ordinance 528 was adopted.

(b) **2016.** The rate of compensation of the Chief of Police for the year 2016 shall be \$31.10 per hour.

(c) **2017.** The rate of compensation of the Chief of Police for the year 2017 shall be \$32.03 per hour.

(d) **2018.**

(1) **In General.** The rate of compensation of the Chief of Police for the year 2018 shall be \$33.57 per hour.

(2) **Retroactive Payment for Period Before Execution of Police Collective Bargaining Agreement.** The provisions of this subsection (d) are retroactive to January 1, 2018. Accordingly, the difference between the compensation earned under this § 11-104.1(d) from January 1, 2018 through the last pay period which ended before the enactment of Ordinance 546 (less all applicable deductions), and the amount actually paid for that period of time, shall be paid to the Chief of Police in the paycheck for the pay period which includes the date Ordinance 546 was adopted.

(e) **2019.** The rate of compensation of the Chief of Police for the year 2019 shall be \$34.58 per hour.

(f) **2020.** The rate of compensation of the Chief of Police for the year 2020 shall be \$35.62 per hour.

(g) **2021.** The rate of compensation of the Chief of Police for the year 2021 shall be \$36.69 per hour.

(h) **2022.** The rate of compensation of the Chief of Police for the year 2022 shall be \$37.93 per hour for the person serving as Chief on January 1, 2022, and \$38.00 per hour for any person hired as Chief of Police in 2022.

(i) **2023.** The annual salary of the Chief of Police for the year 2023 shall be \$74,353.

(j) **2024.** The annual salary of the Chief of Police for the year 2024 shall be \$84,452.55.

§ 11-109 Employment and Appointment at Will.

(2) **Execution.** The President (or Vice President) of Borough Council and the Borough Manager are hereby authorized and directed to execute a collective bargaining agreement in the form approved under paragraph (1).

(3) **Implementation.** All officers, agents, and employees of the Borough are hereby directed to implement the terms and conditions of the executed collective bargaining agreement.

(4) **Inconsistent Ordinances Superseded.** Any provision of the Alburdis Codified Ordinances or any other Ordinance or Resolution which is inconsistent with any of the terms of the executed collective bargaining agreement is superseded to the extent of the inconsistency.

(f) 2018-2021.

(1) **CBA Approved.** Borough Council hereby approves a collective bargaining agreement with the Alburdis Police Officers' Association for calendar years 2018-2021 in the form attached to Ordinance 546.

(2) **Execution.** The President (or Vice President) of Borough Council and the Borough Manager are hereby authorized and directed to execute a collective bargaining agreement in the form approved under paragraph (1).

(3) **Implementation.** All officers, agents, and employees of the Borough are hereby directed to implement the terms and conditions of the executed collective bargaining agreement.

(4) **Inconsistent Ordinances Superseded.** Any provision of the Alburdis Codified Ordinances or any other Ordinance or Resolution which is inconsistent with any of the terms of the executed collective bargaining agreement is superseded to the extent of the inconsistency.

(5) **MOU Approved.** Borough Council hereby approves a memorandum of understanding with the Alburdis Police Officers' Association in the form attached to Ordinance 547.

(6) **Execution.** The President (or Vice President) of Borough Council and the Borough Manager are hereby authorized and directed to execute the memorandum of understanding in the form approved under paragraph (5).

(7) **Implementation.** All officers, agents, and employees of the Borough are hereby directed to implement the terms and conditions of the executed memorandum of understanding.

(8) **Inconsistent Ordinances Superseded.** Any provision of the Alburdis Codified Ordinances or any other Ordinance or Resolution which is inconsistent with any of the terms of the executed memorandum of understanding is superseded to the extent of the inconsistency.

(g) 2022-2024.

(1) **CBA Approved.** Borough Council hereby approves a collective bargaining agreement with the Alburdis Police Officers' Association for calendar years 2022-2024 in the form attached to Ordinance 568.

(2) **Execution.** The President (or Vice President) of Borough Council and the Borough Manager are hereby authorized and directed to execute a collective bargaining agreement in the form approved under paragraph (1).

(3) **Implementation.** All officers, agents, and employees of the Borough are hereby directed to implement the terms and conditions of the executed collective bargaining agreement.

(4) **Inconsistent Ordinances Superseded.** Any provision of the Alburdis Codified Ordinances or any other Ordinance or Resolution which is inconsistent with any of the terms of the executed collective bargaining agreement is superseded to the extent of the inconsistency.

(h) 2025-2028.

(1) **CBA Approved.** Borough Council hereby approves a collective bargaining agreement with the Alburdis Police Officers' Association for calendar years 2025-2028 in the form attached to Ordinance 597.

(2) **Execution.** The President (or Vice President) of Borough Council and the Borough Manager are hereby authorized and directed to execute a collective bargaining agreement in the form approved under paragraph (1).

(3) **Implementation.** All officers, agents, and employees of the Borough are hereby directed to implement the terms and conditions of the executed collective bargaining agreement.

(4) **Inconsistent Ordinances Superseded.** Any provision of the Alburdis Codified Ordinances or any other Ordinance or Resolution which is inconsistent with any of the terms of the executed collective bargaining agreement is superseded to the extent of the inconsistency.

(5) **MOU Ratified and Confirmed.** Borough Council hereby ratifies and confirms the Memorandum of Understanding with the Alburdis Police Officers' Association dated October 29, 2025, a true and correct copy of which is attached to Ordinance 601.

(6) **Implementation.** All officers, agents, and employees of the Borough are hereby directed to implement the terms and conditions of the executed Memorandum of Understanding.

(7) **Inconsistent Ordinances Superseded.** Any provision of the Alburdis Codified Ordinances or any other Ordinance or Resolution which is inconsistent with any of the terms of the executed Memorandum of Understanding is superseded to the extent of the inconsistency.

¶ 11-C Derivation of Unofficial Chapter 27 to 1981 Code (after Ordinance 253).

In 1988, General Code Publishers Corp. printed an unofficial codification of Ordinance 253 to Chapter 27 of the 1981 Code. Borough Council did not formally add Ordinance 253 to the 1981 Code, and did not formally adopt any of the numbering and stylistic changes made by General Code Publishers Corp. This material was omitted from the 2003 Codified Ordinances, and thus repealed.
