## Article I — In General

### § 38-101 Short Title.

This Chapter shall be known, and may be cited, as the “Borough of Albutis Fire Loss Claims Ordinance.”

### § 38-102 Definition.

For purposes of this Chapter, the term “Fire Insurance Escrow Act” means section 508 of the Insurance Company Law of 1921, Act of May 21, 1921 (Pa. Laws 682, No. 284), as added by the Act of July 9, 1992 (Pa. Laws 678, No. 98), and amended by the Act of October 13, 1994 (Pa. Laws. 609, No. 93), 40 PA. STAT. ANN. § 638, as such section may be amended and/or re-numbered from time to time in the future, or any corresponding provision of any future legislation that amends, supplements or supersedes that section.

**§ 38-103 Authorization to Receive Payments from Fire Insurance for Delinquent Borough Taxes and Other Charges, and for Costs Incurred by Borough for Removal or Repair.**

The Borough hereby authorizes the procedure set forth in subsections (a) and (b) of the Fire Insurance Escrow Act (relating to procedures for payment to a municipality of delinquent taxes, assessments, penalties, and user charges against a property, and costs incurred by a municipality for the removal, repair, or securing of a building or other structure on a property, from insurers covering fire loss claims).

**§ 38-104 Authorization to Receive Payments from Fire Insurance to Hold as Security for Costs Incurred by Borough for Removal or Repair.**

The Borough hereby authorizes the procedure set forth in subsections (c) and (d) of the Fire Insurance Escrow Act (relating to procedures for payment of certain fire loss insurance proceeds to a municipality to hold as security against the total cost of removing, repairing, or securing a building or other structure which may be incurred by the municipality, and for the disposition of the security).

**§ 38-105 Designated Officer.**

The Borough hereby designates the Borough Manager as the officer authorized to carry out the Borough's duties under the Fire Insurance Escrow Act.

**§ 38-106 Filing With Pennsylvania Department of Community and Economic Development.**
