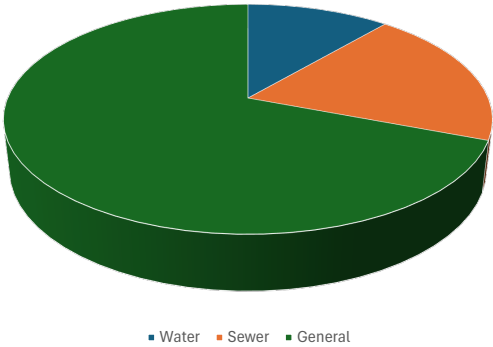
2026 Projected Budget- General Fund



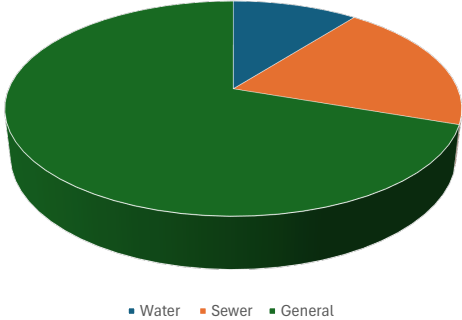

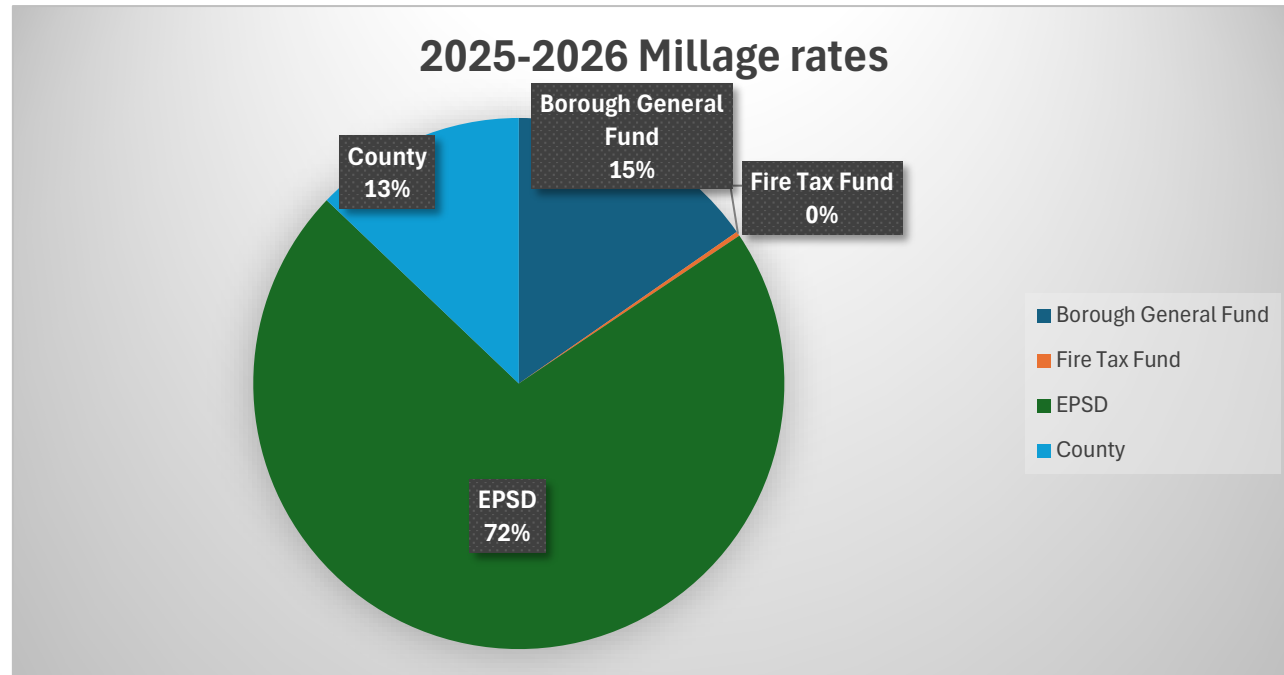
2026 Budgeted Revenues
