Article I — Annexations

§ 2-101 14.0378 Acres to the Southeast.

- (a) **Petition Approved.** The Borough of Alburtis hereby approves the petition of the sole freeholder of the territory proposed to be annexed to the said Borough, Lehigh County, Pennsylvania, being that portion of Lower Macungie Township, Lehigh County, Pennsylvania, adjacent to and southeast of the said Borough, bounded and described as set forth in Section 1 of Ordinance 77, which is incorporated herein by reference.
- **(b) Approval by the Court.** If the annexation of the said territory is approved by the Court of Quarter Sessions, the said territory shall be admitted, annexed to, and added to the Borough of Alburtis as a part of the said Borough, and the same shall, upon compliance with the legal requirements be subject to the jurisdiction of the authorities of the said Borough of Alburtis and shall be entitled to the privileges of the same.

(c) Certification; Filing; Notice. The proper officials of the Borough of Alburtis, as required by law, are hereby authorized and directed to certify to the Court of Quarter Sessions, County of Lehigh, Pennsylvania, the said petition, as approved hereby, and to file in the said Court, a certified copy of Ordinance 77, together with any maps, plots, and descriptions required by law to be filed, and to give proper notice of such annexation to the County board of elections of the said County.

- (a) **Petition Approved.** The petition for the annexation to the Borough of Alburtis of a certain tract of thirty-seven (37) acres, more or less, signed by a majority of the freehold owners, namely: Raymond A. Kemp, Betty J. Kemp, Paul W. Gambler, Catherine Gambler, Amy Kercher, Elmer Kercher, Harold J. Dankel, Lorraine Dankel, Alburtis Recreation Association, Mansko Enterprises Inc., and East Penn Unit School District Authority, is hereby approved.
