AN ORDINANCE SIGNIFYING THE DESIRE AND INTENTION OF THE MUNICIPAL AUTHORITIES OF THE BOROUGH OF ALBURTIS, LEHIGH COUNTY, PENNSYLVANIA, TO ORGANIZE AN AUTHORITY UNDER PROVISIONS OF THE ACT OF MAY 2, 1945, P.L. 382, KNOWN AS THE "MUNICIPALITY AUTHORITIES ACT OF 1945", AS AMENDED AND SUPPLEMENTED, FOR THE PURPOSE OF EXERCISING ANY AND ALL POWERS CONFERRED BY SAID ACT; SETTING FORTH, IN FULL, THE PROPOSED ARTICLES OF INCORPORATION; APPOINTING THE FIRST MEMBERS OF THE BOARD OF THE AUTHORITY; AUTHORIZING EXECUTION OF ARTICLES OF INCORPORATION AND DOING OF ALL MATTERS NECESSARY FOR CREATION OF SAID AUTHORITY; AND RE\* PEALING ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT WITH SAID ORDINANCE.

BE IT ENACTED AND ORDAINED by the Council of the Borough of Alburtis, Lehigh County, Pennsylvania (hereinafter called the "Borough"), and it hereby is enacted and ordained, as follows:

Section 1. The Council of this Borough hereby signifies its intention and desire to organize an Authority under provisions of the Act of May 2, 1945, P.L. 382, known as the "Municipality Authorities Act of 1945", as amended and supplemented (hereinafter called the "Authorities Act"), for the purpose of exercising any and all powers conferred by the Authorities Act.

Section 2. The Burgess, President of Council and Secretary, respectively, of this Borough hereby are authorized and directed to execute, on behalf of this Borough, Articles of Incorporation for such Authority in substantially the following form:

## ARTICLES OF INCORPORATION

# TO: THE SECRETARY OF THE COMMONWEALTH OF PENNSYLVANIA

In compliance with requirements of the Act of May 2, 1945, P.L. 382, known as the "Municipality Authorities Act of 1945", as amended and supplemented, and pursuant to an Ordinance enacted by the municipal authorities of the Borough of Alburtis, Lehigh County, Pennsylvania, expressing the intention and desire of the municipal authorities of said municiplaity to organize a municipality authority under said Act, the municipality hereby does certify:

1. The name of the Authority is "ALBURTIS BOROUGH AUTHORITY".

2. The Authority is formed under provisions of the Act of May 2, 1945, P.L. 382, known as the "Municipality Authorities Act of 1945", as amended and supplemented.

3. No other Authority has been organized under said Municipality Authorities Act of 1945, as amended and supplemented, or under the Act of June 28, 1935, P.L. 463, as amended and supplemented, and is in existence in or for the incorporating municipality Page 2

The Burgess, President of Council and Secretary, respectively, of this Borough hereby are authorized and directed to cause notice of the substance of this Ordinance, including the substance of the foregoing Articles of Incorporation, and of the proposed filing of such Articles of Incorporation to be published once in a newspaper published and of general circulation in the County of Lehigh, Pennsylvania, and once in the legal journal published in and for the County of Lehigh, Pennsylvania, as required by the Authorities Act.

Section 4. The Burgess, President of Council and Secretary, respectively, of this Borough hereby are authorized and directed to cause such Articles of Incorporation, together with necessary proofs of publication, to be filed with the Secretary of the Commonwealth of Pennsylvania and to do all other acts and things necessary or appropriate to effect the incorporation of such Authority, including payment of any filing fees necessary in connection therewith.
