§ 30-1. Declaration of intent.

Alburtis Borough Council hereby signifies its intention and desire to organize an Authority under the provisions of the Act of May 2, 1945, P.L. 382, as amended and supplemented,¹ for the purpose of doing all things necessary for the construction and operation of a sewage waste collection and disposal system for the Borough of Alburtis.

§ 30-2. Articles of Incorporation.

The President and Secretary of Alburtis Borough Council, together with the Mayor, are hereby authorized and directed to

execute, on behalf of said borough, Articles of Incorporation for a Municipal Authority in substantially the following form.²

§ 30-3. Publication of notice.

The President of Council and the Secretary of Council of this borough are authorized and directed to cause notice of the substance of the foregoing Articles of Incorporation to be published as required by the Municipality Authorities Act of 1945.³

§ 30-4. Authorization to officials.

The President of Council and the Secretary of Council of this borough are authorized and directed to file such Articles of Incorporation and the necessary proofs of publication with the Secretary of the Commonwealth of Pennsylvania and to do all other things necessary to effect the incorporation of such Authority, including payment of the required filing fees.
