AN ORDINANCE FIXING THE SALARIES, BONDS AND DUTIES OF BOROUGH OFFICIALS AND EMPLOYEES FOR THE YEAR 1993.

COMPENSATION

Coverage shall be secured and premiums paid by the Borough.
