Ordinance No. 297

(Duly Adopted March 31, 1993)

AN ORDINANCE DESIGNATING SNOW EMERGENCY ROUTES IN THE RIDGEVIEW DEVELOPMENT, INCLUDING ALL OR POR-TIONS OF WEST SECOND STREET, RIDGEVIEW DRIVE, AND FLINT HILL ROAD.

WHEREAS, Sections 6109(a)(1) and (7) of the Vehicle Code, 75 PA. CONS. STAT. § 6109(a)(1),(7), permit municipalities to regulate or prohibit stopping, standing, or parking, and to prohibit or restrict the use of highways at particular places or by particular classes of vehicles whenever the highway may be seriously damaged by the use or the movement of the vehicles would constitute a safety hazard, and Section 201.21(e) and (g) of the Transporation Department regulations, title 67 of the Pennsylvania Code, permits municipalities to designate snow emergency routes on local or state highways within their physical boundaries without an engineering or traffic study; and

WHEREAS, the Borough Council has determined that certain highways should be designated as Snow Emergency Routes within the Ridgeview development in Alburtis; and

WHEREAS, the Borough Council desires that the snow emergency ordinance be recognized as permanent legislation and that snow emergency route signs be permanent rather than temporary;

Now, THEREFORE, be it ORDAINED and ENACTED by the Borough Council of the Borough of Alburtis, Lehigh County, Pennsylvania, that Chapter 129, Article III of the Code of the Borough of Alburtis shall be amended by revising Sections 129-8(E), adding new Sections 129-8(J) and 129-8(K), revising Section 129-9, deleting Section 129-10 (relating to placement of temporary signs), and revising Section 129-11, all to read as follows:

Designation of snow emergency routes. § 129-8.

West Second Street from Main Street to Ridgeview Drive. E. * * *

Ridgeview Drive from Front Street to Avi Drive. J.

К. Flint Hill Drive from Avi Drive to West Second Street.

Marking of routes. § 129-9.

* *

All snow emergency routes shall be marked by signs conforming to the design, placement, and other requirements of Pennsylvania Department of Transportation regulations.

§ 129-10. [Repealed].

Removal of vehicles. § 129-11.

All vehicles parked on streets designated as snow emergency routes under Section 129-8 shall be subject to removal without notice by the Borough of Alburtis upon the proclamation of a snow emergency by the Mayor or by Borough Council.
