## ORDINANCE NO. 304

AN ORDINANCE FIXING THE SALARIES, BONDS AND DUTIES OF BOROUGH OFFICIALS AND EMPLOYEES FOR THE YEAR 1994.

BE IT ORDAINED AND ENACTED by the Borough Council for the Borough of Alburtis as follows:

SECTION 1: The following rates of compensation are hereby established for the year 1994 for the offices and positions of employment set forth below:
