Ordinance No. 312

(Duly Adopted October 26, 1994)

AN ORDINANCE ACCEPTING THE DEDICATION OF WEST FRONT STREET, RIDGEVIEW DRIVE, AND AVI DRIVE IN THE SUBDIVISION KNOWN AS "RIDGEVIEW" IN THE BOROUGH OF ALBURTIS, AND OPENING AND INCORPORATING SUCH STREETS INTO THE OFFICIAL STREET SYSTEMS OF THE BOROUGH OF ALBURTIS; AND RE-ACCEPTING THE DEDICA-TION OF WEST SECOND STREET, FLINT HILL ROAD, AND MOTY DRIVE IN THE SUBDIVISION KNOWN AS "RIDGEVIEW" IN THE BOROUGH OF ALBURTIS, AND OPENING AND INCORPORATING SUCH STREETS INTO THE OFFICIAL STREET SYSTEMS OF THE BOROUGH OF ALBURTIS.

WHEREAS, Borough Council approved a land development and subdivision known as "Ridgeview" by Resolution 1990-1, adopted January 31, 1990, and entered into a Subdivision Improvement/Maintenance/Indemnification/Security Agreement with the developer of Ridgeview as of August 2, 1990; and

WHEREAS, subdivision/land development plans for Ridgeview have been recorded in the Office of the Recorder of Deeds of Lehigh County, Pennsylvania in Map Book Volume 29, at pages 36, 36A, and 36B; and

WHEREAS, as part of the development of Ridgeview, the Developer thereof agreed to create, lay out, and improve to Borough standards certain proposed public streets within the development, known as West Front Street, Ridgeview Drive, and Avi Drive; and

WHEREAS, the Developer has, in fact, created, laid out, and improved the said proposed public streets, which have been duly inspected by the Borough Engineer and accepted as having been constructed to Borough standards; and

WHEREAS, the Developer has dedicated such proposed public streets to the Borough, both through the recording of the plans for Ridgeview, and also by a Deed of Dedication dated September 30, 1994, which was recorded on September 30, 1994 in the

Office of the Recorder of Deeds of Lehigh County, Pennsylvania in Miscellaneous Book Volume 769, page 1163; and

WHEREAS, in accordance with the Municipalities Planning Code and the Borough Code, Borough Council desires and has agreed to accept the dedication of such proposed public streets and to open and incorporate the same into the official street system of the Borough of Alburtis; and

WHEREAS, as part of the development of Ridgeview, the Developer thereof also agreed to create, lay out, and improve to Borough standards certain proposed public streets within the development, known as West Second Street, Flint Hill Road, and Moty Drive; and

WHEREAS, the Developer, in fact, did create, lay out, and improve West Second Street, Flint Hill Road, and Moty Drive; such public streets were duly inspected by the Borough Engineer and accepted as having been constructed to Borough standards; such streets were dedicated to the Borough through the recording of the plans for Ridgeview, and also by a Deed of Dedication dated August 31, 1992, which was recorded on September 3, 1992 in the Office of the Recorder of Deeds of Lehigh County, Pennsylvania in Miscellane-ous Book Volume 687, page 816; and were accepted by the Borough of Alburtis by Ordinance 293, duly adopted December 9, 1992; and

WHEREAS, Borough Council desires to re-accept the dedication of West Second Street, Flint Hill Road, and Moty Drive and to open and re-incorporate the same into the official street system of the Borough of Alburtis in accordance with the provisions of the Borough Code;

NOW, THEREFORE, be it ORDAINED and ENACTED by the Borough Council of the Borough of Alburtis, Lehigh County, Pennsylvania, as follows:

SECTION 1. The Borough of Alburtis hereby accepts the dedication of the following streets in the Ridgeview development, and opens and incorporates the same into the official street system of the Borough of Alburtis:

- "West Front Street", as more fully described in the attached Exhibit A, which is incorporated herein by reference, and as delineated in the attached Exhibit B, which is also incorporated herein by reference;
- "Ridgeview Drive", as more fully described in the attached Exhibit C, which is incorporated herein by reference, and as delineated in the attached Exhibit D, which is also incorporated herein by reference;
- "Avi Drive", as more fully described in the attached Exhibit E, which is incorporated herein by reference, and as delineated in the attached Exhibit F, which is also incorporated herein by reference.

SECTION 2. The Borough of Alburtis hereby re-accepts the dedication of the following streets in the Ridgeview development, previously accepted under Ordinance 293 (duly adopted December 9, 1992), and opens and re-incorporates the same into the official street system of the Borough of Alburtis:

- "West Second Street", as more fully described in the attached Exhibit G, which is incorporated herein by reference, and as delineated in the attached Exhibit H, which is also incorporated herein by reference;
- "Flint Hill Road", as more fully described in the attached Exhibit I, which is incorporated herein by reference, and as delineated in the attached Exhibit J, which is also incorporated herein by reference;
- "Moty Drive", as more fully described in the attached Exhibit K, which is incorporated herein by reference, and as delineated in the attached Exhibit L, which is also incorporated herein by reference.

SECTION 3. Within ten (10) calendar days after the enactment of this Ordinance, the Borough Secretary shall give written notice of the enactment of this Ordinance by United States certified mail return receipt requested to the personal address of the owners of all property abutting on the portions of the streets opened under Sections 1 and 2 of this Ordinance.

SECTION 4. This Ordinance shall be effective thirty (30) calendar days after its enactment (i.e., on November 25, 1994), unless the effective date is stayed by the petition of any interested party during such thirty (30) day period. Such a stay shall continue until Borough Council shall have held a hearing on the petition and acted upon the same by motion, and for thirty (30) calendar days thereafter, or, in the case of further timely appeal to court, until the court shall have finally disposed on the matter.

ALL THAT CERTAIN street or roadway being a portion of West Front Street as shown on the plan entitled Ridgeview as prepared by SSM/Spotts, Stevens and McCoy, Inc., Consulting Engineers, said plan being numbered 8877-003-D-002, situate in the Borough of Alburtis, County of Lehigh, and Commonwealth of Pennsylvania, being more fully described as follows, to WIT:
