BOROUGH OF ALBURTIS LEHIGH COUNTY, PENNSYLVANIA

Ordinance No. 352

(Duly Adopted May 28, 1997)

AN ORDINANCE ACCEPTING THE DEDICATION OF: (A) COBBLESTONE COURT, GOLD ALLEY, MICA ALLEY (EASTERLY PORTION), AND EAST SECOND STREET IN THE SUBDIVISION KNOWN AS "BERI ACRES" IN THE BOROUGH OF ALBURTIS; (B) WINDSOR ROAD IN THE SUBDIVISION KNOWN AS "SUBURBAN HEIGHTS" IN THE BOROUGH OF ALBURTIS; AND (C) FRANKLIN STREET, CHURCH STREET, LAUREN DRIVE, AND THOMAS STREET IN THE SUBDIVISION KNOWN AS "LOCK RIDGE ESTATES" IN THE BOROUGH OF ALBURTIS; AND OPEN-ING AND INCORPORATING SUCH STREETS INTO THE OFFICIAL STREET SYSTEM OF THE BOROUGH OF ALBURTIS.

WHEREAS, Borough Council approved a land development and subdivision known as "Beri Acres" on August 14, 1991, and entered into a Subdivision Agreement with the developer of Beri Acres as of March 23, 1993; and

WHEREAS, subdivision/land development plans for Beri Acres have been recorded in the Office of the Recorder of Deeds of Lehigh County, Pennsylvania in Map Book Volume 31 at page 36; and

WHEREAS, as part of the development of Beri Acres, the Developer thereof agreed to create, lay out, and improve to Borough standards certain proposed public streets within the development, known as Cobblestone Court, Gold Alley, Mica Alley (eastern portion), and East Second Street. (The Borough already owned the western portion of Mica Alley); and

WHEREAS, the Developer has, in fact, created, laid out, and improved the said proposed public streets, which have been duly inspected by the Borough Engineer and accepted as having been constructed to Borough standards; and

WHEREAS, the Developer has dedicated such proposed public streets to the Borough, both through the recording of the plans for Beri Acres, and also by a Deed of

Dedication dated March 4, 1997, which was recorded on March 12, 1997 in the Office of the Recorder of Deeds of Lehigh County, Pennsylvania in Deed Book Volume 1581, page 654; and

WHEREAS, Borough Council approved a land development and subdivision for a portion of property known as "Suburban Heights" on February 14, 1990, and entered into various subdivision agreements with the developer of that portion of Suburban Heights as of September 6, 1990; and

WHEREAS, subdivision/land development plans for that portion of Suburban Heights have been recorded in the Office of the Recorder of Deeds of Lehigh County, Pennsylvania in Map Book Volume 29 at page 38; and

WHEREAS, as part of the development of Suburban Heights, the Developer thereof agreed to create, lay out, and improve to Borough standards a certain proposed public street within the development, known as Windsor Road; and

WHEREAS, the Developer has, in fact, created, laid out, and improved the said Windsor Road, which has been duly inspected by the Borough Engineer and accepted as having been constructed to Borough standards; and

WHEREAS, the Developer has dedicated the said Windsor Road to the Borough through the recording of the plans for the relevant portion of Suburban Heights, and intends to execute and record a Deed of Dedication of the same to the Borough in form satisfactory to the Borough Solicitor within the next thirty (30) days; and

WHEREAS, Borough Council approved a land development and subdivision known as "Lock Ridge Estates" on December 14, 1994, and entered into a Subdivision Agreement with the developer of Lock Ridge Estates as of June 6, 1995; and

WHEREAS, subdivision/land development plans for Lock Ridge Estates have been recorded in the Office of the Recorder of Deeds of Lehigh County, Pennsylvania in Map Book Volume 33 at page 18; and

WHEREAS, as part of the development of Lock Ridge Estates, the Developer thereof agreed to create, lay out, and improve to Borough standards certain proposed public streets within the development, known as Franklin Street, Church Street, Lauren Drive, and Thomas Street; and

WHEREAS, the Developer has, in fact, created, laid out, and improved the said proposed public streets, which have been duly inspected by the Borough Engineer and accepted as having been constructed to Borough standards; and

WHEREAS, the Developer has dedicated such proposed public streets to the Borough through the recording of the plans for Lock Ridge Estates, and intends to execute and record a Deed of Dedication of the same to the Borough in form satisfactory to the Borough Solicitor within the next thirty (30) days; and

WHEREAS, in accordance with the Municipalities Planning Code and the Borough Code, Borough Council desires and has agreed to accept the dedication of such proposed public streets in Beri Acres, Suburban Heights, and Lock Ridge Estates and to open and incorporate the same into the official street system of the Borough of Alburtis;

NOW, THEREFORE, be it ORDAINED and ENACTED by the Borough Council of the Borough of Alburtis, Lehigh County, Pennsylvania, as follows:

SECTION 1. The Borough of Alburtis hereby accepts the dedication of the following streets in the Beri Acres development, and opens and incorporates the same into the official street system of the Borough of Alburtis:

- 1. "Cobblestone Court", as more fully described in the attached **Exhibit A**, which is incorporated herein by reference, and as delineated in the attached **Exhibit B**, which is also incorporated herein by reference;
- "Gold Alley", as more fully described in the attached Exhibit C, which is incorporated herein by reference, and as delineated in the attached Exhibit D, which is also incorporated herein by reference;

- "Mica Alley", as more fully described in the attached Exhibit E, which is incorporated herein by reference, and as delineated in the attached Exhibit F, which is also incorporated herein by reference;
- 4. "East Second Street", as more fully described in the attached **Exhibit G**, which is incorporated herein by reference, and as delineated in the attached **Exhibit H**, which is also incorporated herein by reference;

SECTION 2. The Borough of Alburtis hereby accepts the dedication of the following street in the Suburban Heights development (1990 portion), and opens and incorporates the same into the official street system of the Borough of Alburtis:

"Windsor Road", as more fully described in the attached **Exhibit I**, which is incorporated herein by reference, and as delineated in the attached **Exhibit J**, which is also incorporated herein by reference;

SECTION 3. The Borough of Alburtis hereby accepts the dedication of the following streets in the Lock Ridge Estates development, and opens and incorporates the same into the official street system of the Borough of Alburtis:

- 1. "Franklin Street", as more fully described in the attached **Exhibit K**, which is incorporated herein by reference, and as delineated in the attached **Exhibit L**, which is also incorporated herein by reference;
- 2. "Church Street", as more fully described in the attached **Exhibit M**, which is incorporated herein by reference, and as delineated in the attached **Exhibit N**, which is also incorporated herein by reference;
- 3. "Lauren Drive" and "Thomas Street", as more fully described in the attached **Exhibit O**, which is incorporated herein by reference, and as delineated in the attached **Exhibit P**, which is also incorporated herein by reference;

SECTION 4. Within ten (10) calendar days after the enactment of this Ordinance, the Borough Secretary shall give written notice of the enactment of this Ordinance by United States certified mail return receipt requested to the personal address of the owners of all property abutting on the portions of the streets opened under Sections 1, 2, and 3 of this Ordinance.

SECTION 5. This Ordinance shall be effective thirty (30) calendar days after its enactment (*i.e.*, on June 27, 1997), *provided that*:

- 1. Section 2 shall not be effective on that date unless the developer of the relevant portion of Suburban Heights or its successor has delivered an Opinion of Record Title with respect to Windsor Road to the Borough in form and substance satisfactory to the Borough Solicitor and has executed and recorded a Deed of Dedication of Windsor Road to the Borough in form satisfactory to the Borough Solicitor;
- 2. Section 3 shall not be effective on that date unless the developer of Lock Ridge Estates or its successor has delivered an Opinion of Record Title with respect to the streets descirbed in Section 3 to the Borough in form and substance satisfactory to the Borough Solicitor and has executed and recorded a Deed of Dedication of such streets to the Borough in form satisfactory to the Borough Solicitor; and
- 3. If any interested party shall file a petition for a hearing with respect to any street(s) accepted and opened under this Ordinance in accordance with the Borough Code during said thirty (30) day period, the effective date of this Ordinance *with respect to those streets covered by the petition* shall be stayed until Borough Council shall have held a hearing on the petition and acted upon the same by motion, and for thirty (30) calendar days thereafter, or, in the case of further timely appeal to court, until the court shall have finally disposed on the matter.

THENCE proceeding along the southerly side of East Second Street, South 78° 58' 02" West a distance of 80.00 feet to a point;

THENCE along the lands known as Block B, Lots 1, 2, 3, 4, 5, and 6, the following five (5) courses and distances:

- (1) curve to the right with a radius of 15.00 feet, a central angle of 90° 00' 00", an arc length of 23.56 feet (chord: South 56° 01' 58" East, 21.21 feet) to a point;
- (2) South 11° 01' 58" East a distance of 40.00 feet to a point;
- (3) curve to the right with a radius of 75.00 feet, a central angle of 180° 00' 00", an arc length of 235.62 feet (chord: South 78° 58' 02" West, 150.00 feet) to a point;
- (4) North 11° 01' 58" West a distance of 40.00 feet to a point;
- (5) curve to the right with a radius of 15.00 feet, a central angle of 90° 00' 00", an arc length of 23.56 feet (chord: North 33° 58' 02" East, 21.21 feet) to a point;

THENCE along the southern right-of-way line of East Second Street, South 78° 58' 02" West a distance of 66.04 feet to a point;

THENCE along the same on a curve to the right with a radius of 525.00 feet, a central angle of 01° 28' 53", an arc length of 13.57 feet (chord: South 79° 42' 29" West, 13.57 feet) to a point, the PLACE OF BEGINNING.

CONTAINING approximately 21,399 square feet.
