# BOROUGH OF ALBURTIS LEHIGH COUNTY, PENNSYLVANIA

Ordinance No. 547

(Duly Adopted July 25, 2018)

AN ORDINANCE APPROVING A MEMORANDUM OF UNDER-STANDING WITH THE ALBURTIS POLICE OFFICERS' ASSOCIA-TION TO AMEND THE HEALTH REIMBURSEMENT ARRANGE-MENTS FOR POLICE EMPLOYEES AS PROVIDED IN THIS ORDINANCE; AND AMENDING CODIFIED ORDINANCES SEC-TIONS 20A-403, 20B-403, AND 20C-403 TO PROVIDE THAT REIM-BURSEMENTS UNDER THE BOROUGH'S HEALTH REIMBURSE-MENT ARRANGEMENTS DO NOT REQUIRE FINAL APPROVAL BY BOROUGH COUNCIL AND ARE NOT TO BE DELAYED BASED ON COUNCIL'S MEETING SCHEDULE.

Be it ORDAINED and ENACTED by the Borough Council of the Borough of Albur-

tis, Lehigh County, Pennsylvania, as follows:

**SECTION 1.** Codified Ordinances § 11-201 (relating to Salaries and Compensation—Collective Bargaining Agreements—Police) is amended by adding the following new paragraphs (5) through (8) to subsection (f) thereof:

- (f) 2018-2021.
  - \* \* \*

(5) **MOU Approved.** Borough Council hereby approves a memorandum of understanding with the Alburtis Police Officers' Association in the form attached to Ordinance 547.

(6) **Execution.** The President (or Vice President) of Borough Council and the Borough Manager are hereby authorized and directed to

execute the memorandum of understanding in the form approved under paragraph (5).

(7) **Implementation.** All officers, agents, and employees of the Borough are hereby directed to implement the terms and conditions of the executed memorandum of understanding.

(8) Inconsistent Ordinances Superseded. Any provision of the Alburtis Codified Ordinances or any other Ordinance or Resolution which is inconsistent with any of the terms of the executed memorandum of understanding is superseded to the extent of the inconsistency.

**SECTION 2.** The attached Memorandum of Understanding is incorporated into this Ordinance by reference.

**SECTION 3.** Codified Ordinances § 20A-403 (relating to Health Reimbursement Arrangement for Nonuniformed Employees—Benefits—Time of Reimbursement) is amended as follows (with deletions indicated by strike-outs and insertions indicated by double underlining):

#### § 20A-403 Time of Reimbursement.

Reimbursements under this Plan shall be made at such time and in such manner as the Administrator may prescribe. The Administrator need not make any particular reimbursement until an administratively reasonable period after a Participant submits an appropriate application and documentation under § 20A-402. Payments shall be made following final approval by Borough Council at a public meeting. Payments shall not require final approval by Borough Council, and shall not be delayed based on the meeting schedule of Borough Council.

**SECTION 4.** Codified Ordinances § 20B-403 (relating to Health Reimbursement Arrangement for Police Employees—Benefits—Time of Reimbursement) is amended as follows (with deletions indicated by strike-outs and insertions indicated by <u>double under-</u> <u>lining</u>):

#### § 20B-403 Time of Reimbursement.

Reimbursements under this Plan shall be made at such time and in such manner as the Administrator may prescribe. The Administrator need not make any particular reimbursement until an administratively reasonable period after a Participant submits an appropriate application and documentation under § 20B-402. Payments shall be made following final approval by Borough Council at a public meeting. Payments shall not require final approval by Borough Council, and shall not be delayed based on the meeting schedule of Borough Council.

**SECTION 5.** Codified Ordinances § 20c-403 (relating to Health Reimbursement Arrangement for Dental and Vision Expenses—Benefits—Time of Reimbursement) is amended as follows (with deletions indicated by strike-outs and insertions indicated by double underlining):

### § 20C-403 Time of Reimbursement.

Reimbursements under this Plan shall be made at such time and in such manner as the Administrator may prescribe. The Administrator need not make any particular reimbursement until an administratively reasonable period after a Participant submits an appropriate application and documentation under § 20c-402. Payments shall be made following final approval by Borough Council at a public meeting. Payments shall not re-

<u>quire final approval by Borough Council, and shall not be delayed based</u> <u>on the meeting schedule of Borough Council.</u>

## MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is made this 25<sup>th</sup> day of July, 2018 by and between:

The **Borough of Alburtis**, a Pennsylvania municipal corporation, with offices at 260 Franklin Street, Alburtis, Lehigh County, Pennsylvania (the "**Borough**"); and

The **Alburtis Police Officers' Association**, a Pennsylvania unincorporated association which maintains an address at 5426 Doris Drive, Allentown, Lehigh County, Pennsylvania (the "**Association**").

The Borough and the Association, as parties to a Collective Bargaining Agreement for calendar years 2018 through 2021 ("**CBA**"), hereby agree that the Borough shall adopt an ordinance amending §§ 20B-403 and 20C-403 of the Alburtis Codified Ordinances as follows (with deletions indicated by strike-outs and insertions indicated by <u>double underlining</u>), and shall maintain those provisions as so amended throughout the term of the CBA:

## § 20B-403 Time of Reimbursement.

Reimbursements under this Plan shall be made at such time and in such manner as the Administrator may prescribe. The Administrator need not make any particular reimbursement until an administratively reasonable period after a Participant submits an appropriate application and documentation under § 20B-402. Payments shall be made following final approval by Borough Council at a public meeting. Payments shall not require final approval by Borough Council, and shall not be delayed based on the meeting schedule of Borough Council.

### § 20C-403 Time of Reimbursement.

Reimbursements under this Plan shall be made at such time and in such manner as the Administrator may prescribe. The Administrator need

not make any particular reimbursement until an administratively reasonable period after a Participant submits an appropriate application and documentation under § 20c-402. Payments shall be made following final approval by Borough Council at a public meeting. Payments shall not require final approval by Borough Council, and shall not be delayed based on the meeting schedule of Borough Council.
